There will be an update on an earlier deliverable report (data transfer). There will be an updated version for the consent form of phase 2 soon, and the plan is still to submit the protocol for phase 2 in October to ethical committees.

7. WP7

The last WP7 meeting was very constructive, and discussed the following points:

-Communication across centers needs to be improved

- -Weekly Wednesday mornings are now planned and helpful
- -WP7 has their timelines clear now, request for all other WPs to provide their timelines to share with the whole SC. This need to worked on before the next SC meeting and will be discussed there.
- -The manual is nearly finalized as a priority.

Since it became difficult for Movisens to keep moving due to delays, there are now people assigned to different tasks and made responsible for their tasks. We need to make sure we are using the workforce we have available.

A full draft of the requirements document will be ready by the end of this week, and in the Mannheim meeting next week all necessary docs for Movisens will be finalized.

There's still input needed on visualization, Inez will reach out to Peter and Daniel.

D8.2 (Dissemination plan) is coming up in September. We already have a lot described in the original application, so that will be used as a base doc, and elaborated on for the deliverable report. This plan is dynamic, in the sense that it will keep getting updated throughout the project.
