Rationale Behind Data Set Papers



- **Mandatory citation for those who use relevant Phase I data, as long as the paper is written after the Data Set paper has been published 😊**
- **Documents size, scope, and limitations of each data set**
- **Each paper can link to repository with detailed description of codes and variables**
